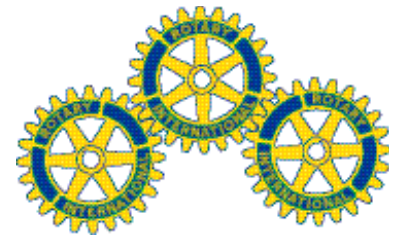

PROGRAM

Andree Langlois is an interior designer with experience in residential, commercial, and health care facilities. She has extensive experience in applying A.D.A. standards for accessible design in commercial projects and is author of the Residential Universal Design Guide, a Manual for Architects, Interior Designers and Builders. A native of Quebec, she holds a Master of Arts Degree in Interior Design from SFSU. Ms. Langlois teaches barrier-free design at SRJC where she is an Adjunct Instructor in Interior Design.

The Americans with Disabilities Act was introduced to Congress in 1989 and signed into law the next year by President George W. Bush. Twenty-two years later, 53 million people are

impacted by the ADA—previously unable to leave their homes, board on buses, and get to stores, theatres and sports events. California was the state most affected by the law when, in 1992, the California Civil code made it a violation of state law prohibiting discrimination in our state on the basis of disabilities in employment, state and local government, public accommodations, commercial facilities, transportation and telecommunications. Because of ADA, disability became any physical or mental impairment that substantially limits one or more major life activities. Costs of compliance, remedies and legal actions for non-compliance can be tremendous and has become one of California’s major industries. In 20 years, it is estimated that almost half of the population will be over 65 and will have one or more disabilities.
