And this month, seven more scholars graduated from the University of Colima, bringing their total number of college grads to 34! The mission of this worthwhile project is obvious: to enable the poor children of Colima to reach their highest potential by providing educational opportunities, material support, enrichment activities, and medical and dental services not otherwise available to them. We help pay for scholarships to outstanding students who complete sixth grade so that they can attend junior & senior high, and college at the University of Colima. If you've read the two letters recently from students graduating from Colima High School this year it is so evident that staying in school is changing their lives. What a benefit for those we can help!
